PROXY INFORMATION

If you are unable to attend the reorganization meeting, you may designate another voting member as your proxy. The request must be submitted in writing to the Secretary of the County Party. Email proxy requests to Secretary LaDonna Freeman at: freeman@indydemocrats.com. Proxy requests must be received by Saturday, March 6th, 2021 at 8 AM EST - Additionally, you may mail your proxy request to LaDonna Freeman, Secretary, Marion County Democratic Party, 114 W Saint Clair Street, Indianapolis, IN 46204. The postmark date will not be considered. If we do not have your proxy by 8am on March 6th, the proxy will not count. Please provide the following information in your proxy request:

- Name of voter requesting proxy
- Voter number of voter requesting proxy
- The name of the individual who will carry this proxy

All proxy requests must be in writing by the deadline - no exceptions

HOW TO RUN

In order to qualify to run for one of the four positions being voted on, an individual must meet the following requirements as defined by Indiana Democratic Party Rule 13(c):

- (A) is a Party member, as set forth in Rule 8(c);
- (B) is a qualified voter; and
- (C) resides in the county in which he or she is a candidate

Those interested in running for County Chair, Vice Chair, Secretary, or Treasurer must send notice of their candidacy in writing to the Secretary of the Marion County Democratic Party. Per Indiana Democratic Party State Central Committee rules, declarations must be received no later than Wednesday, February 24, 2021 at 10 AM EST. Email declarations of candidacy to Marion County Democratic Party Secretary LaDonna Freeman at: freeman@indydemocrats.com. Additionally, you may mail your declaration to LaDonna Freeman, Secretary, Marion County Democratic Party, 114 W Saint Clair Street, Indianapolis, IN 46204. Declarations must be received by Wednesday, February 24th, 2021 at 10 AM EST. The postmark date will not be considered.

All candidate filings must be in writing by the deadline - no exceptions
